







The RCGP net zero consultancy service matches a practice with a trained adviser who will work closely with the team to develop a decarbonisation plan. The plan includes a baseline assessment of the practice's current carbon use and emissions; agreed reduction targets, and a prioritised list of actions the practice can take as they work towards reducing their impact on the environment. Carbon Literacy is an awareness of the carbon costs and impacts of everyday activities and the ability and motivation to reduce emissions, on an individual, community and organisational basis.

22nd May 2023 The Health and Care Professions Council (HCPC) which regulates 13 of the 14 allied health professional groups, has opened a formal consultation on Reviewing the standards of conduct, performance and ethics | (hcpc-uk.org). Adding sustainability in health and care has been proposed and will be discussed as part of the consultation process. HCPC is running a workshop on sustainability, and we encourage any members involved in these professions to join the workshop and support the addition of this theme in the revised standards. 6th **June 2023:** The Centre for Sustainable Healthcare runs regular <u>carbon literacy courses</u> for health professionals and quality improvement leads. It offers an understanding of what a carbon footprint is, how it can be used in the health sector's endeavour to go net zero and how it is measured.

14th **July 2023** The Net Zero Clinical Care Conference is 14 July 2023 at BMA House, London | Free

The conference will provide insights for health and care professionals on how they can help the NHS achieve its net zero target by 2040 whilst also improving the quality of patient care. The conference will enable action, build awareness and create a community.

WHICH review 'How much does your appliance cost to run'

Plastics and the Environment. The Minderoo-Monaco Commission on Plastics and Human Health has produced an extensive analysis of the plastics' negative impacts on: i) human health and well-being focusing on vulnerable populations, ii) on the global environment focusing on ocean health, and iii) the economy. The report includes highly valuable sustainable solutions that can be implemented by governments and industries to minimize the negative consequences of global plastic contamination.

Health impact assessment: estimating the health impacts of an ICS Green Plan. For anyone interested in green plans this Jan 2023 <u>report</u> aims to link carbon reduction commitments with local health outcomes. This is a challenging process due to uncertainty and limited data but, by



improving ICS Green Plan governance and data collection now, this connection - and the ability to demonstrate impact - will become clearer in future.
